- 25 years of age or older & responsible leaders with youth.
- Will accept guidelines set by the District Board & Youth Camp Board.
- <u>Dress Code:</u> All staff members will be wearing sleeves to the elbow and always act and dress as becomes a
 Christian.
- For Men:
 - o In keeping with the unity of the District, we ask that there be no mustaches or beards.
 - No hair on the collar and ears.
- For Ladies:
 - o The dresses of the ladies will be worn so as to cover the knees.
 - o Necklines will be modest and decent Tight fitting clothes shall not be worn.
 - o Gauchos, skorts, or split skirts above the knees will not be permitted.
 - No makeup or jewelry (necklaces, earrings, bracelets, etc.) will be allowed.
